You'd think with the end of summer and tourist season that Association activities would slow down. Wrong!

We are in the process of submitting proposals to various corporations to seek financial sponsorship of the 2002 Cruise. Griffin Food Company is the first we are contacting. If they decline, we will then try Love's and Express Personnel.

We are in the process of filling out the paperwork to designate Oklahoma Route 66 as a Scenic Byway. We're not talking a few pages here – we're talking 43 pages filled with questions – questions that often are more relevant to a 3-mile stretch of road than 400 miles.

We are working on the State Historic Preservation Office Route 66 Road documentation project, funded with Route 66 Corridor Act monies. This is a comprehensive road documentation project that includes detailed mapping, photos and a descriptive narrative. Historic bridges, roadside parks, FAP markers and sections of original paving are all a part of what has to be documented. Our end of the project must be turned in by January 15th.

We are trying to fill several vacancies in our county rep positions. This is critical as we must delegate Trip Guide sales, cruise checkpoint coordination, and other responsibilities. First of all, our Bylaws demand it. And from a purely physical and psychological point of view, the officers and Executive Director can no longer run the show by themselves. We are growing too big and we have many important events and projects coming up that will require county by country assistance.

We also need to fill the office of Executive Director – see next column.

And we are beginning to work on the actual Trip Guide update and the 2002 Cruise and Car Show.

Chandler Lights of Remembrance to show concern

Thousands of "Lights of Remembrance" have gone up on the historic old Chandler armory, lit nightly in tribute to all those lost or missing in the September 11 U. S. terrorist attacks. The lights are also in remembrance of their families, the rescue workers, bio-terrorism victims and those killed in other attacks against the United States around the world including the bombing of embassies at Kenya and Tanzania.

The more than 12,000 lights also signify remembrance of the 168 victims of the 1995 Oklahoma City federal building terrorist attack. Four of them had close ties to Chandler, a similar percentage of victims as New York City suffered. The Chandler census report was 2,900 population.

Chairman of the "Lights of Remembrance" committee is Kim Austin, longtime friend and Chandler classmate of one of the victims, HUD

attorney Susan Ferrell. Committee members include Ferrell's sister, Chandler attorney Cindy Ashwood, parents Don and Sally Ferrell, and cousins David and Terri Ferrell of Chandler. Also Mike Bay and Chandler fireman Bobby Johnson.

The special holiday tribute is sponsored by the Old Armory Restorers (OARS), an organization of Chandler citizens working to restore the abandoned old armory building in the middle of town.

"As National Guard troops are deployed to active duty for safety of Americans and to combat terrorism, it is especially significant that the lights will be at the old armory which saw citizen soldiers go to World War II and Korea," said chairman Austin. The giant native stone armory has been abandoned for 20 years, and the preservation-minded OARS group hopes it is soon to be returned to community uses as well as an Oklahoma Route 66 Welcome Center. Built in 1937, it is listed in the National Register of Historic Places.

Any contributions above lighting project expenses will go to September 11 relief funds being collected by the Union Bank of Chandler. For information about lighting contributions, call Kim Austin, 405-258-0593 or Cindy Ashwood, 258-0097.

Other big news besides the lighting project:

(1) The National Trust for Historic Preservation has awarded a Preservation Services Fund grant of \$1,000, to be matched, to fund professional research and planning for the old Chandler armory's restoration.

(2) State Senator Kelly Haney came to Chandler Friday, Nov. 9, to announce a \$100,000 grant appropriation for the project to be funded by the Oklahoma Historical Society.

(3) a new Chandler Community Development Trust Authority has been formed to lease the building from the city, carry out fundraising, restoration, management. As well as other community uses, initial goal is establishing the Oklahoma Route 66 Welcome Center there.

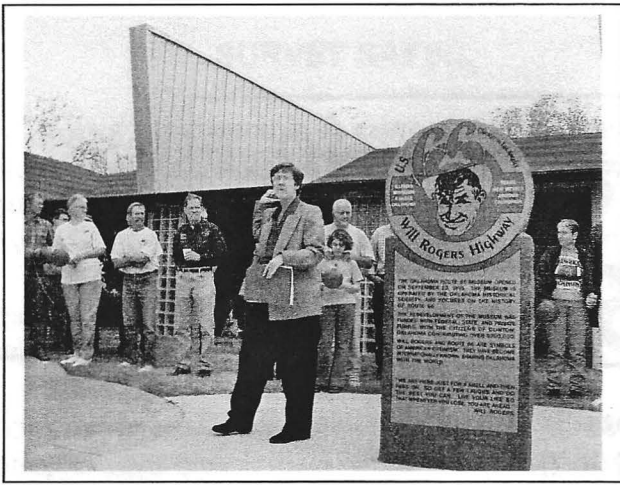

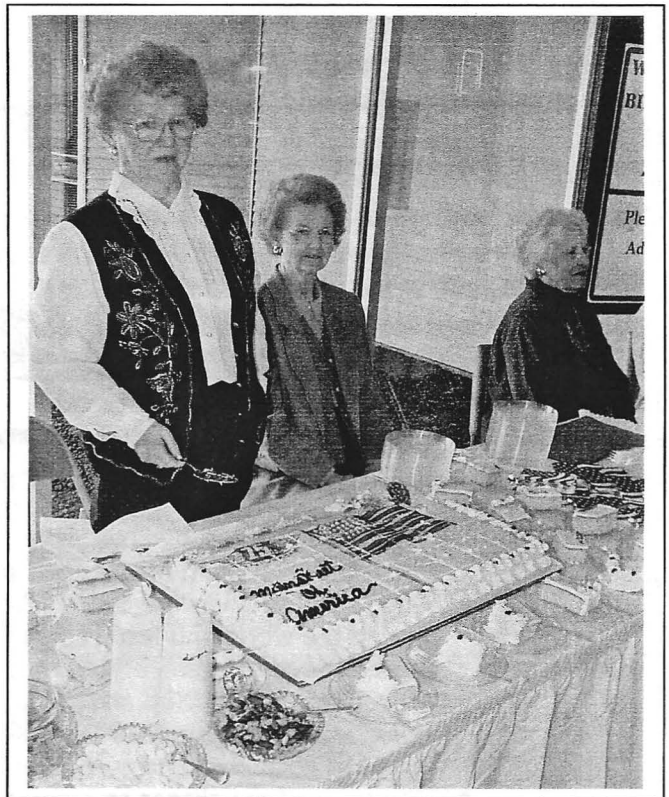
A Plea to All Route 66 Associations

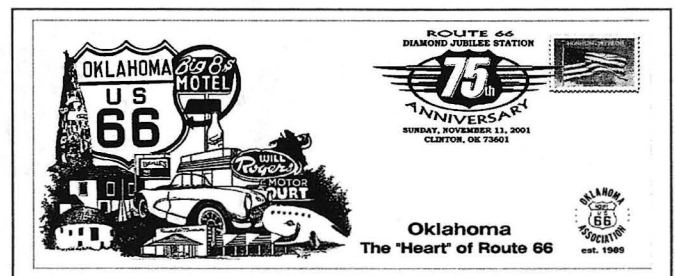

Limited Edition Postmark Envelope/Cachet Still Available

For those of us who love nostalgia, collectibles and all things Americana, a unique, limited edition special commemorative postmark envelope/cachet is still available through the Oklahoma Route 66 Association to honor the 75th Anniversary of Route 66.

The envelope features two custom pieces of art (see page 5). The first design is imprinted on the linen envelope itself. A montage of pen and ink-style vintage Oklahoma Route 66 landmarks shares space with a special slogan about Oklahoma and the official logo of the Oklahoma Route 66 Association.

The second custom piece of art is the actual postmark. The striking design is adapted from the official Oklahoma Route 66 Association 75th Anniversary logo which is used only during the year 2001. This unique postmark was only available from the Clinton, Oklahoma post office and, like all event postmarks, was destroyed 30 days after first issue.

To complete the special cachet, the Association chose the stirring "Honoring Veterans" flag stamp. This stamp proved to be extremely popular nationwide and is now out of print.

The date of first issue, appropriately enough, was November 11th – which has the twin distinctions of being the official 75th Anniversary "birthday" of Route 66 and Veteran's Day. The envelope's rarity is further demonstrated by a Sunday postmark.

Only 1000 cachets were printed. They are available in white or cream linen envelopes with either black or blue ink for the postmark. Bicycle Trail on OK 66?

The Association has been contacted twice by Percy Walker, OK State Representative, District 60, about an idea that was brought to him by several folks out in western Oklahoma. They were wondering about the feasibility of turning the abandoned two north lanes that run for several miles between Sayre and Erick (which were the original alignment prior to expansion into four lanes) into a bicycle trail. So Representative Walker called us to see if we thought the idea had merit and what were possible avenues to pursue in terms of seeking funds to clean-up and trim back the overgrown trees and bushes that line

and sometimes choke the abandoned lanes. We told him we thought it was a great idea and then we brainstormed awhile on finances.

Recently, Rep. Walker called again with an update. The funds they are seeking through the Department of Transportation (probably TEA21 funds) require that the pathway actually connect two points. So it looks like the bicycle trail would start near the washed-out bridge on the older alignment in Sayre, follow the older route out of town, then swing over to the abandoned north lanes, and eventually wind up somewhere in Erick. Whether a parallel bicycle path would be built where bikes would have to share the road with vehicles is unclear.

Rep. Walker was also curious as to whether anyone else had converted abandoned sections of 66 into bicycle trails. We assured him that no one in Oklahoma had and, based on our admittedly limited out-of-state knowledge, that although the Chain of Rocks Bridge had been converted, no road segment had – especially for that distance. This news seemed to cheer Rep. Walker, giving him, we assume, a strong and unique twist to the project.

We also offered the services of any Association members who might want to volunteer if the western group decided to hold a clean-up day to cut down trees and brush, clean up broken glass, etc. We know many of you are eager to get involved in some sort of preservation/restoration project and this one would certainly be a good one.

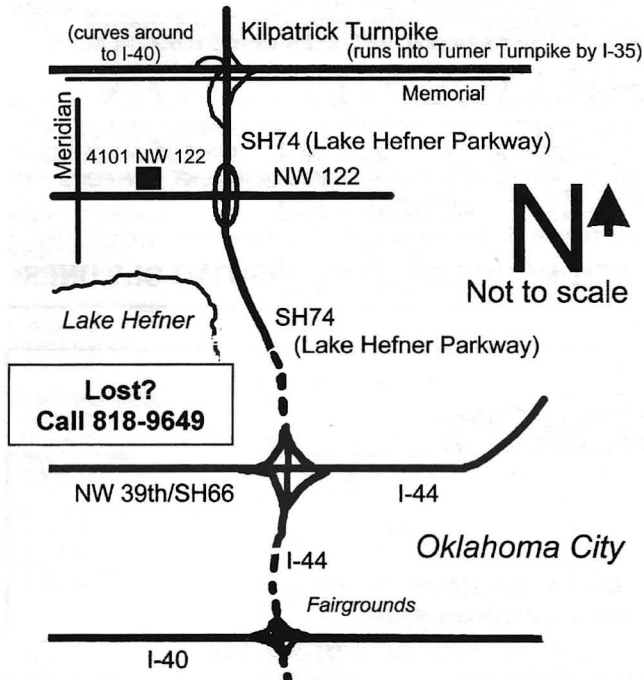
Two Route 66 Icons Now Only History

Also, the 66 Motel on the west side of Tulsa was torn down, to make way for a mini-storage unit facility. The sign is to be refurbished and put back up on the site.

Directions from the south: take I-44 or I-40 to I-44 to SH74, which is locally known as Lake Hefner Parkway and go N. Take the NW 122nd exit, turn left over the Parkway, then go approx. .4 to .5 mile to 4101 NW 122, which is right after the Augusta Apts., on the N side of the road. If you go too fast, you'll miss the Prudential Building and entrance to the Country Club Office Park II.

Directions from the north/Turner Turnpike: When leaving Turner Turnpike go straight and join the Kilpatrick Turnpike. The next exit you want (a high ramp) is marked "74 South/Hefner Pkwy." As you are merging onto 74 the next exit is for NW 122nd. Take the exit, turn right at the light, go approx. .4 to .5 mile to 4101 NW 122, which is right after the Augusta Apts. on the N side. Don't go too fast - you'll miss the turn into the Country Club Office Park II.

4101 NW 122: this is the Prudential Bldg. Look for Route 66 sign at entrance to parking lot. Building entrance is on the west side; doors will be open and signs will direct you to the conference room.

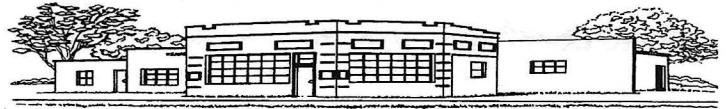

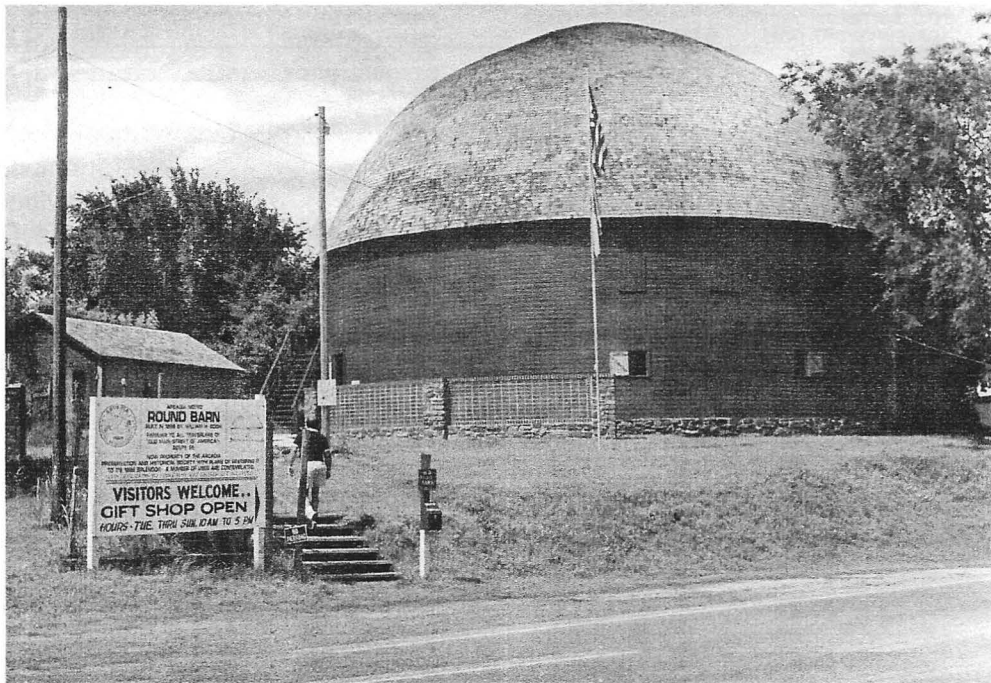
